**TERMS and CONDITIONS.** The undersigned "Applicant" hereby applies for credit with JFTCO, Inc., and its affiliated companies including but not limited to Fabick Cat and Fabick Rents (collectively "Fabick Cat") and/or Lincoln Contractors Supply, Inc. ("LCS"); Fabick Cat and LCS are collectively referred to herein as ("Creditors").

Applicant understands and agrees that it is applying for commercial (non-consumer) credit with Fabick Cat and/or LCS. Creditors are authorized to conduct further inquiry as to the credit worthiness of Applicant, but are not obligated to do so, and are entitled to rely upon the accuracy and completeness of the information provided herein, whether or not further inquiry is conducted. Applicant agrees to pay interest on past-due balances at 1 1/2% per month, or the highest rate of interest permitted by law, whichever is lower, as well as all costs of collection, including all reasonable attorneys' fees.

If there is a material change in the information contained herein, Applicant agrees to immediately notify Creditors in writing. Applicant agrees that Creditors may periodically inquire with others about Applicant's credit status, and provide others with information concerning Applicant's credit history with Creditors. Applicant shall pay all charges associated with its account according to the terms of this application and applicable invoices.

Creditors' receipt and review of this Application does not constitute authorization or approval of credit, or any specific credit amount. Applicant's submission of this Application does not imply any obligation to extend credit to Applicant and Creditors may refuse credit to Applicant at any time and for any reason, with or without notice, in their sole and exclusive discretion, except for reasons prohibited by law.
